RESOLUTIONS for AFLC Evangelism and Discipleship (AED)

1. WHEREAS found in Matthew 28:19-20 there is a call to evangelize and make disciples.

AND WHEREAS the AED has a purpose statement: "to make and equip disciples who make and equip disciples."

BE IT RESOLVED that we encourage all congregations to train and equip disciple-makers.

2. WHEREAS the Bible teaches that God is "well-pleased through the foolishness of the message preached to save those who believe" (1 Corinthians 1:21); and "How beautiful are the feet of those who bring good news" (Romans 10:12-15); and Ephesians 4:12-13 challenges God's leadership to "equip the saints for the work of service, to the building up of the body of Christ";

AND WHEREAS the Fundamental Principles also urge congregations to gladly accept "The mutual assistance which congregations can give one another in the work for the advancement of the Kingdom of God,"

BE IT RESOLVED that the Annual Conference encourages congregations to pray, plan, prepare and then invite Lutheran evangelists, pastors, and gospel-centered teachers (Eph. 4:11) for special evangelistic and discipleship ministries aimed at reaching lost souls for salvation through Christ Jesus while encouraging and training the saved in their spiritual walk with Christ.

BE IT FURTHER RESOLVED that we encourage the use of the AED Speaker Program and other AED resources to assist in proclaiming the gospel message.

3. WHEREAS the theme of the 2021 AFLC Annual Conference is "Prepare the way of the LORD" (Isaiah 40:3);

BE IT RESOLVED that we encourage the use of the AED department, and their library of resources (found on their website) to help prepare for evangelistic meetings and/or congregational discipleship training.

4. WHEREAS Ephesians 4:3-6 states to "being diligent to preserve the unity of the Spirit in the bond of peace"

BE IT RESOLVED that we encourage sister AFLC Ministries to continue to seek ways to partner with the AED when there are shared goals and purposes.

BE IT FURTHER RESOLVED that AFLC congregations and districts prayerfully consider getting involved in the regional conferences "Reawakening to the Mission" being held by AED and other AFLC sister ministries.

5. WHEREAS the Pastoral and Congregational Care Team (PACCT) has been established to support pastors, their wives, and congregations for encouragement during times of personal crises and/or congregational conflict;

AND WHEREAS a fund has been created where our people can financially participate in the team's ministry,

BE IT RESOLVED that we encourage every congregation in the AFLC to prayerfully consider utilizing PACCT "prevention, intervention, and recovery" resources and possibly contribute to the PACCT fund.

BE IT FURTHER RESOLVED that the Annual Conference would ask for an written and verbal annual report from PACCT.

6. WHEREAS the AED is pursuing the much needed development of in-house produced Evangelism and Discipleship materials and Website development;

BE IT RESOLVED, that each congregation and every individual prayerfully consider supporting the AFLC Evangelism and Discipleship Ministry through prayer and finances,

AND BE IT FURTHER RESOLVED, that after prayerful consideration, we approve the subsidy request for 2022 of \$132,500.

RESOLUTIONS for the Benefits Board

1. WHEREAS the Holy Scriptures teach: "Let the elders who rule well be considered worthy of double-honor, especially those who labor in preaching and teaching. For the Scripture says, 'You shall not muzzle an ox when it treads out the grain' and, 'The laborer deserves his wages" (1 Tim. 5:17, 18);
