

o be a Christian and to walk in the Light is an impossibility, except one has received the Holy Spirit. Romans 8:9 reads, "But ye are not in the flesh, but in the Spirit, if so be that the Spirit of God dwell in you. Now if any man have not the Spirit of Christ, he is not in Christ (a Christian) if the Spirit of God is not indwelling in us. The indwelling Holy Spirit of God in us is the very proof that we are His children. That is why Jesus tells us in John 14:16-18, "And I will pray the Father, and he shall give you another Comforter, that he may abide with you for ever; even the Spirit of Truth; whom the world cannot receive, because it seeth him not, neither knoweth him; but ye know him; for he dwelleth with you, and shall be in you. I will not leave you comfortless; I will come to you."

There are some who believe and teach that we receive the Holy Spirit some time later after receiving Jesus Christ as Lord and Saviour. This is not true according to the Scriptures. In Ephesians 3:13 we read, "... in whom also after that ye believed, ye were sealed with that Holy Spirit of promise." It is the Holy Spirit who gives us the assurance that we are the children of God. To try to be a Christian without the Holy Spirit in our hearts and lives is impossible. God is a Triune God. God the Father, God the Son and God the Holy Spirit are one and cannot be separated.

Men can somewhat understand, through the reading of the Scriptures, that God is the Almighty One, who is over all and who created all things. How precious the words of Jesus become. "Come unto me, all ye that labor and are heavy laden, and I will give you rest" (Matthew 11:28). For they have forsaken me and made this a place of foreign gods; they have burned sacrifices in it to gods that neither they nor their fathers nor the kings of Judah ever knew, and they have filled this place with the blood of the innocent. They have built the high places of Baal to burn their sons in the fire as offerings to Baal - something I did not command or mention, nor did it enter my mind.

So beware, the days are coming, declares the LORD, when people will no longer call this place Topheth or the Valley of Ben Hinnom, but the Valley of Slaughter (Jeremiah 19:4-6).


here was my dead son lying in his own placenta in an ice cream pail." Those were the words of a woman from northern Saskatchewan, my home province, after the staff at the hospital in Brandon, Manitoba, showed her her dead baby. She had made the choice of aborting her child because the doctors told her the baby would likely have water on the brain and spina bifida. The woman was advised by her lawyer not to take legal action, and when she wrote a letter of complaint to the hospital, the executive director said some changes would be made so that it would not happen again. Oh, the director was not referring to the abortion, for they will continue to kill babies there and put them in ice cream pails, but from now on they will try to make sure that women who have abortions are not ever shown their dead babies.

"On the counter sit a dozen or so clear plastic suction bottles holding cloth bags filled with the previous day's POC (products of conception). Inside each one the liquid formaldehyde is now stained dark red with blood. I'm told it's my job to open each bottle and examine the contents, then to prepare tissue for a microscope to verify a successful abortion. No one warned me this was to be my gruesome task, I thought in silent protest. Why should I have to look at them?

"I remove the bag from the first bottle and cut it open with scissors. In a bed of mulched and bloody tissue I immediately recognize tiny parts - human parts - arms, legs, intestines, rib cage, lungs, liver and heart — perfect parts ...

"I complete my task for that first day, as I will for the next 179 working days. At an average of ten per day, just 20 minutes work, I will dissect approximately 1,800 abortions. The popular argument of the age - that it is the right of a woman to do as she wishes with her own body - seems incomprehensible as I stare into the face of a dead child. Those mothers don't have to look. Even the abortionists needn't look,"

This was the testimony of Lorraine Keess, a



registered nurse who worked at a pathology laboratory in the city of Calgary ("Western Report" November 12, 1990). After 179 days, she couldn't take it anymore, and quit.

The reports keep pouring in from throughout the nation concerning the slaughter of one of its weakest minorities. In all of the major centers across the land hundreds and even thousands are dying a painful death by poisoning, suffocation, and decapitation, within the confines of the back rooms of government funded institutions. The numbers keep mounting. The reality is bloody, and there is no end in sight. The nation has been transformed into a cradle of blood.

The words the Lord gave the prophet Jeremiah are just as applicable to our nations and world today as they were to Judah 2,600 years ago. The sacrifice of the unborn children today, like the sacrifice of the children in Jeremiah's day, is the result of paganism, which is the rejection of our Living Lord and His Kingdom for the worship of the false idols of our day. The idols of materialism, sex, pleasure, and money, often demand the sacrifice of the children before they will give the "fulfillment" that their worshippers desire.

"No, the option of retreat from the world is not available to the followers of Christ."

Our Lord Jesus referred to Satan as a liar and a murderer from the beginning. The evil one has sold the world, our nations, and many false prophets and teachers within the institutionalized churches the big lie that children are not, as God's Word teaches, a gracious gift from the Lord, but rather an economic and social burden that we have to destroy. Our world, led by the prince of darkness, has declared war on children, particularly unborn children.

What are we to do in the face of this horrifying reality of Satan's destruction of the unborn?

As believers, we continue in daily repentance and daily seeking to love and serve the Lord our God with all of our heart. soul, mind, and strength, and our neighbors as ourselves, in order that the people around us might know that Jesus Christ is Lord, and come to glorify Him with their lives. This is our overall mandate and goal, and includes bringing the Law and the Gospel to bear on the reality of abortion.

To proclaim the Law of God to our nation and world is to clearly affirm, in word and deed, the reality that unborn children are living human beings created in God's image, and are protected by His commandment against murder.

To proclaim the Law is to be willing to oppose and confront those who, on the basis of secular humanism, deny the sanctity of the life of the unborn, and to warn of the coming judgment of the Lord upon them if they do not repent.

To proclaim the Law is to fight for legislation that clearly affirms and does not compromise the lives of the unborn, and once again makes abortion illegal.

To proclaim the Gospel is to clearly affirm, in word and deed, the sufficiency of the cross of Christ in dealing with the sin of abortion. It is to

share with women who have had abortions and with those who have performed and promoted abortions that Christ died to forgive their sin. If they are willing to cry out for His mercy and forgiveness, "God is faithful and just and will forgive us our sins and purify us from all unrighteousness" (I John 1:9).

We must also reach out with compassion to support and help women in difficult circumstances who choose to bear their children.

Dear friends, the Lord calls us to proclaim the Law and the Gospel not only in words, "but in actions and in truth" (I John 3:18).

The kingdom of heaven is near! The day of the wrath of the Lord is near! The blood of 50 million unborn children a year cries out to the Lord for justice, and His justice will come quickly! When our Lord comes may He find us, as individuals and as a body of believers, busy with the task of sharing in word and deed His law and gospel with the fallen and lost world in which we live, to the salvation of souls and to the glory of the Father and of the Son and of the Holy Spirit! Amen! Come Lord Jesus!

bortion takes the life of one-third of America's and more than one-half of the world's new babies. Every abortion stops a beating heart and an active brain. While these simple facts are staggering, the church appears to be asleep on the watch (Ezekiel 3:17-19) and has grown cold (Matthew 24:11). What are we so busy doing that we continue unaware or unconcerned about this holocaust (II Timothy 3:1-5)?

I believe that the abortion crisis is first a call to personal and corporate repentance. Personal repentance is the process of realizing that you are misguided and need to redirect your life. At least 100 million Americans have been "personally" involved in a "decision of support" for the more than 25 million legal abortions since 1973. The need is clear. Many will try to redirect their lives by self-will, motivated by worldly sorrow, but God wills that we be redirected by a trusting faith in Jesus (II Corinthians 7:9-10). This personal salvation is God's first priority for your life (II Corinthians 6:2).

Corporate repentance is also needed for the church and for our nation. We should all know that most Protestant churches (even most Lutheran churches) take a public stand for the "right to kill" and even sponsor hospitals doing so (Romans 1:32). Our government has a public policy of defending the "choice to kill." Our media provides the inspiration to keep the satanic bandwagon rolling. The nation of Israel has often returned to God and been restored through public repentance (II Chronicles 7:14). We can, too (Revelation 2:4-5).

Along with personal and corporate repentance must also come the "works" of our faith (James 2:18). God commands us to "deliver those who are being taken away to death" (Proverbs 24:11). All should be involved in some aspect of the life movement ... supported by prayer.

RESOLVED, that we encourage prayerful support for the development of alternatives to abortion programs, providing compassionate help for those in need; and be it further

RESOLVED, that we boldly proclaim Law and Gospel, which alone can change the sinful hearts of men and women and turn them from sin to salvation.

From Issue to Involvement

THE STORY OF ONE WOMAN'S PRO-LIFE WITNESS

wish it could be said that my concern for the rights of the unborn traced as far back as 1973, the year the Supreme Court legalized abortion on demand. However, it would take several years before I understood the serious nature of the issue. Although I became aware of the problem in 1970, it was not until 1982 that I became active in the pro-life movement.

It was in 1970 that the governor of New York signed into law a bill that legalized abortion in my home state. I have a vague recollection of observing the New York State Assembly in debate over this controversial issue. At the time, however, I hardly understood the moral and ethical implications.

As the years went by, I did come to realize that abortion is the willful

destruction of human life. The issue became clear to me in the summer of 1982 when my husband preached a series of messages on the Ten Commandments. His sermon on the Fifth Commandment really hit home, as he declared abortion to be murder. This message, with graphic descriptions of the methods and procedures of abortion, was the spark that ignited my passion for wanting to end the slaughter of the unborn.

My involvement in the pro-life movement was limited at first. However, opportunities opened and increased as I became a pro-life participant. Writing letters to the editor and to elected officials became a natural part of my involvement. I joined "Sanctity of Life" marches, picketed pro-abortion politicians, attended state pro-life conventions, and shared in the behindthe-scenes phone calling. The ultimate thrill was the "Rally for Life 1990" last April in Washington, D.C.

Lately the focus of my involvement has shifted. The people I truly admire are the dedicated volunteers who staff the Crisis Pregnancy Centers. They personally involve themselves in the lives of confused young women. What these people do will perhaps accomplish more to save the unborn than all the letters, phone calls and marches.

I am still active in the pro-life movement. But my greatest involvement is demonstrating a pro-life attitude as a way of life, beginning at home. Educating my children on the sanctity of human life as well as the sanctity of marriage and sex is first and foremost. As I instruct them and instill godly values, they will carry these values into our communities and world.

A Mother's Testimony

I Took My Place in a **Picket** Line

ave you ever taken the time to picket an abortion chamber? Just once? Five years ago I would have said no. But the Lord convicted and challenged my husband and me through people who were already directly involved, to be committed physically, spiritually and financially.

We went to Fargo's abortion chamber to picket with other concerned citizens. What an eye opener to actually see "real" people, "ordinary" people going into the "clinic"! This was not a pleasant experience emotionally, but it brought the reality of abortion up close - real close! We were encouraged as the picketers stopped for prayer and prayed for the women having abortions and for those involved in killing the babies.

Recently, I went back to Fargo's abortion chamber expecting to see the usual handful of people picketing but instead saw a lone women a block away holding a sign. (She had been restricted from the premises.) How alone and helpless I felt walking solo in front of this so called "Health Clinic." I thought of how isolated each woman must have felt even in

the midst of others — many thinking this was the only "answer" to their situation.

In my hand I held vital information to give a pregnant woman an alternative to this deception, which destroys a human baby and scars the mother for life. This pamphlet included people and ministries who would help and support their decision for life. How ironic that I also held information on healing and forgiveness for women who came out of the "clinic" after having had an abortion.

Although I cannot picket on a regular basis, the Lord gently reminds me that abortions are still happening at an alarming rate and my responsibility is to share Jesus with others! When we neglect prayer, God's Word, and our responsibility to be an active citizen, we get callous and indifferent to sin and the needs of others. If you and I are "not willing that any should perish," then we will go beyond the comfort of our fellowship with believers to those who need Christ!

FORGIVEN

ne night while my mother tucked me and my little sister into bed, she asked us to kneel, fold our hands and say a prayer to God to help us in a difficult time. As she began to pray, I saw the tears running down her cheeks. Who is this God? I thought to myself. That prayer time was my introduction to God.

Life was not easy for Mother after my father left her three years earlier. Food was often in short supply. We felt isolated. Whoever this God was, apparently He made things better, and, although my mother seldom mentioned His name again, the memory of that night when we prayed stayed with me. The seed had been planted, but was not watered for many years.

My home situation did not seem to affect my early school years. Good grades came easily, and I even won third place in a national spelling bee.

My family was so proud of me, especially Ona and Opa (Grandma and Grandpa in Dutch). They were my strength and stability. Then Opa died, and I thought that God was terrible to take him away from us. Next Ona slowly killed herself with medication that she was not supposed to take.

I began to rebel. As a teenager, my regard for life was almost nothing. I ran with a bad crowd and acquired a felony juvenile record when I was only thirteen years old. Drug use soon followed, and I became sexually active.

My mother knew what was going on and tried to intervene. But I simply rebelled even more.

The night before my sixteenth birthday I tried to commit suicide by taking prescription medications. I felt totally unable to deal with anything, convinced that life as a teenager was the worst thing anyone could be. Then my boyfriend left me for another girl, and no drugs were available to ease the pain. I wrote a letter to God that night, asking Him to take my life. But He had a different plan, and my life was spared.

Finally I did drop out of school and moved out of my mother's house. Later I attended night school and received my diploma, and for three years I lived a very independent life and made a good living. However, it was then that I became addicted to "crank," a form of extremely potent "speed." Soon I could not cope with anything, with or without the drug. My father fortunately stepped into my life at this time and helped me get off "crank." It was the best thing he ever did for me.

At age 20 I decided that it was time to leave my home state of California and join the Air Force. I was to report for duty in six months, but, in the meantime, I became pregnant. I did not even know who the father was.

My only choice seemed to be abortion. I had no other answer. A friend at work confided that she once had one. and told me that it was really simple.

Three days later I was scheduled at the clinic. The morning of the appointment I awoke in tears. It dawned on me that I was going to take a life, and I got the shakes. But my friend took me to the clinic, and I do not remember too much more. Yet the memory of feeling a life being sucked out of me remains.

Complications arose, and I was back at the clinic in two days. Emotionally, I felt guilt and shame. But I always was taught not to look back when I made a decision about something. Just live with it.

I became even more promiscuous over the next few months, and spent money that I did not have. There was no intention in my mind of ever paying off my credit card purchases. I resigned from my job as an account executive two months early, and looked forward to the Air Force. It was a chance to get away from everything.

Military service was good for me in many ways. I was now drug free, and then the man came into my life who was to become my husband. It was in

Germany where we met. We fell in love, and soon I was pregnant again.

Another abortion seemed to be the only solution. The only obstacle was an Air Force regulation which forbade it. I visited a German doctor who recommended a clinic in Holland, but once again the so-called simple procedure was complicated by apparently unsterile instruments. I recovered physically with the help of pain killers and antibiotics, but emotionally we both tried to forget that we ever made that trip into Holland.

My time in the service was brief, however, since my husband soon completed his term. He was the first to accept Christ as His Saviour, and then, when I was 24 years old, Jesus Christ came into my heart! Finally we could together forgive each other and truly find God's forgiveness.

The four years after my last abortion were filled with extreme pain, as well as guilt and shame, to say the least. Sometimes I felt like those years were wasted, but now I know that they were necessary for me to willingly answer my Lord's call. He is my saving grace. He has given me life to start over again. He has given me a wonderful family, as our marriage has been blessed with two healthy children. I now have what I never thought possible, and I thank Him for these blessings every day.

It has been hard for me to write this. But I have a story to tell. I am sure that God has a plan for this article to reach someone who needs it. Perhaps it will save the life of an unborn child. If I had known the agony that goes with the taking of a life, I would never have had an abortion. Even now the feeling of emptiness sometimes comes over me, and I yearn for my other two children. But I rest in the confidence that they are in God's arms and that He is taking care of them for me.

It is quite strange to look back at how I was then and how I am now. It is even more wonderful to look into my children's faces. They are two of the reasons for me to go on in life. God knew this. He is gracious.

Even if every state in the union, say all but one, made laws opposing abortion, that one state would soon become an abortion clinic or an abortion mill,

At one time these United States tried to maintain unity between the states with some states tolerating slavery and some opposing it. It took a civil war to settle this issue.

Surely a federal law, prohibiting abortion, a law which will cover every area of this land, giving legal protection for abortion to no one or to any area, is needed. Only a federal law will accomplish this.

It is God who said, "Thou Shalt Not

Kill." We believe God was referring to human life as He made this commandment. All knowledge and evidence available indicates that the new life within a pregnant woman is human, can feel, hear, move, have a strong desire to live, and will grow and develop if allowed to do so. Therefore, to kill this new life is nothing short of murder.

Surely God will not look favorably upon those who advocate abortion, and they will have to give an account to God for their action some day.

Does any mother have the right to choose to murder her own unborn baby? Certainly not! For any mother who carries within herself such a growing life has the God-given responsibility to bring that new life into this world and to nourish, protect, and train that life to be a God-fearing citizen of this world. A WOUND THAT WILL NOT HEAL

bortion. An elderly friend informed me that it was once considered crude to even say the word in mixed company. But eighteen years ago the United States Supreme Court ruled in Roe vs. Wade that abortion was a woman's constitutional right, and the word has become a common part of our social and political vocabulary. Millions of women have chosen abortion instead of childbirth, and our nation seems more deeply divided than ever over it.

The friction will not fade away. The wound will not heal.

There seems to be no choice for the Christian who is committed to the authority of the Word of God. Our hearts ache for victims of rape and incest. Iniquity abounds, and our sin-sick world bears its awful scars. But we cannot escape the clear teaching of Scripture that speaks of life in the womb (Job 31:15; Job 10:8, 10-12; Psalm 139:13-16; Ecclesiastes 11:5; Isaiah 44:2; Jeremiah 1:5; Luke 1:44). The destruction of this life cannot be a debatable issue.

The AFLC stands on the side of life, including the lives of unborn children. Our annual conference has clearly expressed this commitment, but the individual Christian citizen is called to live it. Many are involved in local and statewide "pro-life" associations; some have stood in picket lines and participated in sidewalk counseling. Our Lutheran doctrine of the two kingdoms is not a defense for doing nothing.

Sanctity of Human Life Sunday is January 20. It is an opportunity for congregations to celebrate the gift of life, as well as to consider the current conflict over abortion. Some of the articles in this issue may serve as a resource for our readers as they struggle with the question of their own involvement.

A commitment to life includes much more than opposition to abortion. The explanation to our catechism reminds us that the fifth commandment has both a negative and positive application:

Thou shalt not kill.

What does this mean?

We should fear and love God so that we do our neighbor no bodily harm nor cause him any suffering, but help and befriend him in every need.

A consistent commitment to life calls us beyond the politics and pickets to a more difficult and demanding task. The wound that will not heal is in the heart. People

need the Lord. A consistent message of sin and grace must be proclaimed by those in pulpit and pew. People need to see the love we proclaim in deed.

May we praise God for the gift of life! May it please God as His people celebrate and commit themselves to the care of life ... including the unborn, but not limited to them.

AMISH DOLLS AND BUDGET GOALS

ur family visited an Amish settlement several years ago while attending the LEM Family Bible Camp near Burton, Ohio. We were captivated by the old-fashioned clothing and the horse-drawn carriages. A number of shops featured shelves full of interesting craft items, including the fascinating Amish dolls.

An Amish doll doesn't have a face. It is blank where the features should be because of their interpretation of the Old Testament prohibition against graven images.

What do Amish dolls and budget goals have in common?

Sometimes a budget does not seem to have a face, either.

Studies suggest that the current generation of church members is less motivated in their giving than previous generations by traditional appeals to meeting the budget. Lyle E. Schaller, author and consultant, maintains that one of the contributing factors to the decline of the mainline denominations was a decision to ask members to give to a budget rather than to causes, with the result that many members began to channel their contributions to organizations that promoted a cause.

A cause is not a faceless budget goal. A cause is a need. A cause is ministry. A cause is people.

The budget of the AFLC is a cause. It has many faces ... missionaries and national workers in Brazil, Mexico and India, faculty members, staff and students at our seminary and Bible school, business administrators and bookkeepers, custodians and cooks, pastors and printers, evangelists and editors.

The month of January is the end of our fiscal year. The various ministries of the AFLC are in need of your prayers and gifts. Look into the faces of our budget goals, and you will see that the need is not only to meet them but to exceed them.

In all your ways acknowledge Him, and He will make your paths straight."

Home Missions in the 1990s

hat does the future hold? What will our world be like by the year 2000? We must always proceed with caution when trying to forecast the future, but there are several key signs worth watching in the 1990s. Cities will continue to grow at an alarming rate. Those with a population of 100,000 people or more will possibly reach 4,200 in number. Mexico City is projected to be the largest city in the world by the year 2000, with perhaps 32 million people. The world is changing at awesome speed. There are and will be many more open doors for the ministry of the Word of God in large and small communities during this decade.

Three words highlight the challenge before us in AFLC Home Missions for the 1990's. The first word is FOCUS, based on Philippians 3:13, "Brothers, I do not consider myself yet to have taken hold of it. But one thing I do:

Forgetting what is behind and straining toward what is ahead ..." Paul's focus was "the prize of the high calling of God in Christ Jesus." Everything he did in life was aimed in that direction. Everything else was "loss compared to the surpassing greatness of knowing Christ Jesus my Lord." This will continue to be the focus of Home Missions in the 1990's. Jesus said, "For where your treasure is, there your heart will be also" (Matthew 6:21). Our treasure is found in Christ and everything we do must be FOCUSED in Him.

The second word is FORGET. It is also found in Philippians 3:13, "Forgetting what is behind ..." The past is important. We can learn from past mistakes and the success God has given us, but the past must not hinder us in the present and future. Pride in past accomplishments can be a barrier. Pride in not admitting past failure can also be a barrier to the future. We must

not dwell on either one, but humble ourselves and move on in God's grace. God's forgiveness is our only avenue of FORGETTING and pressing on to the goal in Christ Jesus.

The third word is FORGING AHEAD, "straining toward what is ahead" (Philippians 3:13). What is ahead in the 1990s? We do not know, but we must keep moving forward step by step as the doors open and God provides for the needs of Home Missions. They will not be easy days and will require new commitment to God's work. Let us give ourselves to the work that God calls us. Let us draw encouragement from the African missionary David Livingston, who said:

"Lord, send me anywhere, Only go with me.

Lay any burden on me, Only sustain me.

Sever any tie but the tie That binds me to Thyself."

The two Montana churches welcome the prayers of other AFLC friends during this time of preparation and for the trip itself, and encourages continual prayer for Gabriel Mercado as he faithfully ministers in northern Mexico.

or the Love of Children is a ministry that has grown out of Minnesota Valley Free Lutheran
Church in Lakeville, Minnesota. Our purpose is to educate families and encourage action and support for prolife and pro-family issues. The work of this ministry is a response to the tremendous need for Christians to become actively involved in shaping the direction of our nation's future.

For the Love of Children is over two years old and began with three Christian friends meeting to discuss pro-family issues. As friends, we have a mutual burden for the survival of traditional family values. We also share the belief that only a movement of prayer and action within the Christian community will turn back the tide of moral destruction and decay in this country. Our response to these convictions soon culminated with the planning of a church ministry proposal.

The vision for a pro-family ministry was welcomed at Minnesota Valley with a volunteer education team and leadership advisors. Our tasks are numerous. Within our congregation we frequently address issues through bulletin inserts, the church newsletter or announcements. For the Love of Children also sponsors a video library with children's and family videos as an alternative to video rental and TV. Along with the videos, we have established a very active education library with a continuing supply of Christian classics and newly released books. These books either provide encouragement for families or address pro-family

Our major ministry outreach is a quarterly newsletter called, "The Family Messenger." We share this resource with other AFLC churches and individuals. In our writings we cover legislative updates with information on contacting representatives and news stories effecting Christians and pro-lifers. We have also provided analysis of issues such as humanistic and New Age education, sex and AIDS edu-

cation, government day care policies and many other pro-family issues. For the Love of Children helps families stay up-to-date by consolidating piles of information into a brief newsletter.

Within the church family we have the opportunity to share and discuss our role in confronting the various battles we face. We also have the fellowship and prayer support needed for the courage to protect our families and to go out into the world and fulfill the cultural mandate given by our Lord.

At Minnesota Valley, the struggle to preserve the Christian values we cherish has resulted in a great deal of action. Many have shared "The Family Messenger" newsletter with friends and family. Others have become involved in the pro-life movement and have attended rallies, written letters, or picketed businesses that support abortion. Also, a Public School Awareness Committee has been formed to address the many concerns within the schools.

This action can make a difference. Often destructive public policy and legislation are approved because the community was not informed. Letters, phone calls, and letters to the editor are steps to change.

Another blessing from Christian involvement in family issues is the amazing opportunities to witness our

faith and to stimulate interest among non-Christians.

Chuck Colson has said that, in order to reverse our downward trend, we must change the way people view things and we must reach them "one by one." We are a small ministry, but, for each person we touch, the potential is great for touching many more.

For the Love of Children's theme verse is: "For God hath not given us a spirit of fear; but of power and of love, and of a sound mind" (II Timothy 1:7). We ask your prayers for this ministry, especially that we humbly live out God's gifts of power in the name of Jesus, the approach of Christian love on every issue, and the discernment of sound minds.

Our ministry has been blessed by the participation of a number of AFLC congregations. We invite any individual or church not receiving our newsletter to do so. Illinois District Meets

Grace Free Lutheran Church, DeKalb, hosted the fourth annual meeting of the AFLC Illinois District on Saturday, November 10. Host pastor Harry Gimberg welcomed the assembly, and later shared a biographical testimony. The sessions were led by Bob Christian, Newark, district vice-president, and Cliff Jerde, DeKalb, opened the morning hour with Scripture reading and prayer.

Pastor Curt Emerson, Shakopee, Minnesota, who was conducting evangelistic meetings in the Brodhead-Janesville parish, served as the featured speaker in the absence of Dr. Steve Lombardo, whose illness led to a last minute cancellation.

AFLC Vice-President Robert Lee, who presently serves in the district, presented an update on our schools and missions, and Cliff Seldal spoke on behalf of the Association Retreat Center (ARC) as chairman of the board. Lay Pastor Mark Olson reported on the district youth ministries, highlighting a recent retreat in Morris with over 120 in attendance.

Video presentations from Janesville, Wisconsin, and Chillicothe, Illinois, acquainted delegates with the progress of these two home mission congregations, and Jim Boe, Ottawa, reported on the building program of Faith Lutheran Church. The convention discussed favorably the possibility of planting other new churches in the area.

Elected as the new district president was Pastor John Skeie, Morris, succeeding Pastor Dennis Gray, who moved to Greenbush, Minnesota, last summer. Merv Mathison, DeKalb, was re-elected to the office of treasurer. Those who continue to serve as officers are Bob Christian, and Pastor Mel Meyer, Norway, the district secretary.

The decision was made to continue to request a voluntary contribution from district congregations of twenty dollars per hundred members. It was also decided to seek a gift of one hundred dollars per congregation designated for district youth ministries.

BOLIVIA — This South American Nation is witnessing a significant movement among evangelical Christians to amend the constitution by including a statement of religious freedom. Thousands of signatures are being added to petitions calling for an end to the

Roman Catholicism. President Pia Zamora, who addressed the first national presidential prayer breakfast last January, assured the evangelicals of his support. One of the leaders of this movement is Felipe (Philip) Kittelson, executive director of the Bolivian Association of Evangelicals. He is the son of former missionaries, Odell and Mar-

NEW YORK - Richard John prominent Lutheran Neuhaus. spokesman, was received into the Roman Catholic Church on September 8, and is presently preparing to enter the priesthood. Neuhaus, a former Missouri Synod theologian who became a member of the ELCA, has publicly declared for several years that the separated existence of Lutheranism is no longer necessary or justified. His liberal theology was overshadowed in recent years by a conservative social/political agenda, and he has been a vocal critic of mainline Lutheranism.

INDONESIA — Evangelical missions in this populous nation of islands are facing a serious crisis, according to a news report in *Christianity Today* (11-19-90). The government of Indonesia, the largest Moslem nation in the world, has recently openly denied visa extensions to missionaries, after years of increasingly difficult regulations and delays imposed upon them. Reports of revival among some of the tribal peoples make this an especially urgent call to prayer, that the Lord would permit the door for Indonesian missions to remain open.
